

As per para V(D)(1)(ii)&(iii) of the notification, "(ii) MoEF shall issue an order constituting the CPIO and the first Appellate Authority of appropriate ranks in consultation with Government of Maharashtra; (iii) details of the Slum Rehabilitation Scheme, including the complete proposal and the names of the eligible slum dwellers will be declared suo-moto as a requirement of Section 4 of compliance of the Right to Information Act, 2005 by the appropriate authority in the Government of Maharashtra in one month before approving it;".




**Sub: Implementation of provisions of Coastal Regulation Zone Notification, 2011 issued vide S.O.No.19(E), dated 6<sup>th</sup> January, 2011- regarding.**

\*\*\*\*

This has reference to the issue of the Coastal Regulation Zone Notification, 2011 vide S.O.No.19(E), dated 6<sup>th</sup> January, 2011. As per para 4(a), *"No untreated sewage, effluents, ballast water, ship washes, fly ash or solid waste from all activities including from aquaculture operations shall be let off or dumped. A comprehensive plan for treatment of sewage generating from the coastal towns and cities shall be formulated within a period of one year in consultation with stakeholders including traditional coastal communities, traditional fisherfolk and implemented;"*. The following are required to be carried out by the State/Union territory Coastal Zone Management Authority:-

- (i) To issue directions under Section 5 of Environment (Protection) Act, 1986 to all municipal bodies, industrial units, ports, thermal power units, oil and gas exploration companies, coastal mining bodies, owners of the boat-houses and aquaculture units, directing them to stop discharging untreated effluents/dispose solid waste in the coastal and marine areas.
- (ii) A comprehensive plan involving reputed scientific institutions shall be prepared for identification and treatment of the sewage generated from coastal towns and cities. The plan shall include treatment facilities and disposal mechanism of the treated effluents.
- (iii) Based on the comprehensive plan which shall be prepared within one year from the date of receipt of this letter, the Authority shall implement the plan in phased manner in consultation with stakeholders.


This has reference to the issue of the Coastal Regulation Zone (CRZ) Notification, 2011 vide S.O.No.19(E), dated 6<sup>th</sup> January, 2011. As per para 4(b), "for those projects which are listed under this notification and also attract EIA notification, 2006 (S.O.1533 (E), dated the 14<sup>th</sup> September, 2006), for such projects clearance under EIA notification only shall be required subject to being recommended by the concerned State or Union territory Coastal Zone Management Authority (hereinafter referred to as the CZMA)."

2. As per the above para the projects which attract Environmental Impact Assessment (EIA) Notification and are categorised as 'B' shall be considered under Environmental Impact Assessment Notification, 2006 by the State Environment Impact Assessment Authority after obtaining prior recommendations from the concerned Coastal Zone Management Authority. The project proponent shall provide all information/reports/filled-in proforma as stipulated under EIA Notification, 2006 and para 4.2 of the CRZ Notification, 2011.

3. For those projects which are listed as 'A' category under the EIA Notification, 2006 and also attract CRZ Notification, 2011, for such projects the project proponent shall first obtain the recommendations of the concerned State/Union territory Coastal Zone Management Authorities after submitting all requisite document/reports in accordance with para 4.2 of the CRZ Notification, 2011 to the concerned CZMA.

4. In case of those projects which do not attract EIA Notification, 2006 but attract only CRZ Notification, 2011 as indicated at para 4(ii), such projects would require clearance from Ministry of Environment and Forests which will be considered in accordance with the procedures laid down in para 4.2.

As per para 3(iii) of the Notification, "*Setting up and expansion of fish processing units including warehousing except hatchery and natural fish drying in permitted areas:*".

**Sub: Implementation of provisions of Coastal Regulation Zone Notification, 2011 issued vide S.O.No.19(E), dated 6<sup>th</sup> January, 2011- regarding.**

This has reference to the issue of the Coastal Regulation Zone Notification, 2011 vide S.O.No.19(E), dated 6<sup>th</sup> January, 2011. As per para (iii) of the Notification, *"the land area falling between the hazard line and 500mts from HTL on the landward side, in case of seafront and between the hazard line and 100mts line in case of tidal influenced water body the word 'hazard line' denotes the line demarcated by Ministry of Environment and Forests (hereinafter referred to as the MoEF) through the Survey of India (hereinafter referred to as the SoI) taking into account tides, waves, sea level rise and shoreline changes."*

2. With regard to the demarcation of the hazard line the Ministry has already initiated the activity with Survey of India under the World Bank assisted Integrated Coastal Zone Management Project. The inception report of this project is available on the website ([www.ncscm/sicom](http://www.ncscm/sicom)). The methodology for demarcation of the hazard line which is published in a newsletter of Society of Integrated Coastal Management in Volume 3 is enclosed for reference.
3. Under the above project the hazard maps would be made available to all the coastal States by end 2012 and the installation of pillars and geo-coding along the hazard line will be carried out between 2012-2015.
4. Till such time the hazard maps are made available the jurisdiction of the CRZ area shall not be reduced less than 500mts on the seafront and 100mts or width of the creek whichever is less along the tidal influenced water bodies as stipulated at para (i) and (ii) of the Notification.
5. If certain areas along the coastal stretches have been declared as hazardous zone by National Disaster Management Authority, State and Union territory Governments from the point of natural disasters in such areas the activities may be regulated.
