Ninety Seventh (97th) meeting of the Maharashtra Coastal Zone Management Authority (MCZMA) was held under the Chairmanship of Principal Secretary (Environment), GoM on 23rd January, 2015 at 1 pm at Sachivalay, Gymkhana, Mumbai. List of Members present in the meeting is enclosed as Annexure-I.

Item No1: Proposal of Installation of Chatrapati Shivaji Maharaj Statue and Memorial in the Arabian Sea at Mumbai

The Public Works Department (PWD), Government of Maharashtra has proposed the Installation of Chatrapati Shivaji Maharaj Statue and Memorial in the Arabian Sea at Mumbai.

The Authority noted that MoEF, New Delhi published new draft notification dated 11th Dec, 2014 to amend the CRZ Notification dated number S.O.19 (E) dated 6th January, 2011 for construction of memorials/ monuments/ allied facility by the concerned State Govt in CRZ IV (A) area in exceptional case with adequate environmental safeguards subject to following the procedure prescribed in clause No. (b) for appraisal of the project by MoEF, New Delhi.

In compliance to said draft notification dated 11th Dec, 2014, the Public Works Department (PWD) being a project proponent vide letter dated 21.1.2015 submitted a proposal for compliance of prescribed procedure in clause (b)(i) pertaining to justification for locating the project in CRZ area along with details of alternate sites considered and weightage matrix on various parameters including environment parameters.

PWD has considered various parameters namely accessibility, space availability, heritage point of view, safety point view including the environmental parameters (Marine Ecology, Marine Environmental, Socio Economic Aspect, Terrestrial Environment) for preparation of weightage matrix for every site identified. The Authority examined the said weightage matrix prepared by PWD. As per the said weightage matrix prepared for every site, the Authority observed that the site proposed in Arabian Sea which is an elliptical outcrop away from 1.2 km from Rajbhavan & 3.2 km from Girgoan Chowpatty (H2O jetty) is the justified location with highest score of 72 for installation of Chatrapati Shivaji Maharaj Statue and Memorial.

The Authority examined from the point of view of environmental issues and felt that this site is the most suitable from the point of view of environmental concerns.

The Authority after examination decided to recommend to MoEF the said location i.e. Site No. 4 of the proposal of PWD to obtain Terms of Reference (ToR) for preparation of Environment Impact Assessment (EIA) Report by PWD.

MINUTES OF THE 97th MEETING OF MAHARASHTRA COASTAL ZONE MANAGEMENT AUTHORITY (MCZMA) HELD ON 23RD JANUARY, 2015

Ninety Seventh (97th) meeting of the Maharashtra Coastal Zone Management Authority (MCZMA) was held under the Chairmanship of Principal Secretary (Environment), GoM on 23rd January, 2015 at 10.30 am at Sachivalay, Gymkhana, Mumbai. List of Members present in the meeting is enclosed as Annexure-I.

Proposed Coastal Road project, by MCGM Item No. 2:

The Authority noted that MCGM vide letter dated 22.1.2015 made a representation mentioning that it is necessary to amend the MoEF notification of 2011 for Coastal Road project as a permissible activity to enable construction of coastal road by reclamation in sea and mangroves. It was further requested to MCZMA to propose necessary amendment to MoEF notification of 2011 and forward to MoEF at the earliest.

The Authority noted that the CRZ Notification, 2011 provides for construction of road on stilt in CRZ I area in MCGM area. However, construction of road/coastal road by way of reclamation is prohibited. Therefore, following amendments are recommended as below:

1. Amendment required in paragraph 3 of sub-paragraph (iv) (a) is as follows:

for item 3.(iv).(a); the following item shall be substituted

3. (iv)(a) Land Reclamation, bunding or disturbing the natural course of seawater except those.-

(a) required for setting up, construction or modernisation or expansion of foreshore facilities like port, harbours, jetties wharves, quays, slipways, bridges, sealink, road on stilts, coastal roads by way of reclamation in sea and in mangroves without the benefit of future commercial or real estate development on the landward side, keeping the existing HTL demarcated in approved CZMP same in its effect and taking it as a reference for appraisal of all other projects from CRZ point of view, as if there was no coastal road and such as meant for defence and security purpose and for other facilities that area essential for activities permissible under the notification.

2. Amendment required in paragraph 4 of sub paragraph (i) is as follows:

After item 4(i)(f) following shall be inserted.

(g) construction of coastal road by way of reclamation in sea and mangroves area in exceptional cases to be decided by concerned CZMA.

Ninety Seventh (97th) meeting of the Maharashtra Coastal Zone Management Authority (MCZMA) was held under the Chairmanship of Principal Secretary (Environment), GoM on 23rd January, 2015 at 01.00 pm at Sachivalay, Gymkhana, Mumbai.

List of Members present in the meeting is enclosed as Annexure-I.

<u>Item No.1:</u> Proposal of installation of Chhatrapati Shivaji Maharaj Statue and Memorial in the Arabian Sea at Mumbai by PWD

Minutes of the matter is approved and signed.

Item No.2: Proposed Coastal Road project in Mumbai by MCGM.

Minutes of the matter is approved and signed.

Item No.3: Hon'ble High Court order dated 20.12.2014 in WP No. 9488/2014 (Aparanta Hotels Private Limited & Anr Vs Union of India through its Secretary, MoEF & ors)-Commercial Building on plot No.7-B, Sector No.11, CBD, Belapur, Navi Mumbai by M/s. Aparanta Hotel

The Authority noted that the Hon'ble High Court of Mumbai has passed an order dated 20.12.2014 in the WP No. 9488/2014 Aparanta Hotels Private Limited & Anr Vs Union of India through its Secretary, MoEF & ors. As per said order, the application made by the petitioners, if any, for grant of No Objection Certificate is till pending, 3rd respondent shall decided the application as expeditiously as possible in accordance with Law.

Project proponent (PP) presented that the Development permission on plot No. 7, Sector No. 11, C.B.D. New Bombay for construction of three star/ commercial Building was granted by the CIDCO vide letter dated 20.12.1993. CIDCO vide letter dated 20.12.1993 also granted commencement certificate (CC) to the project. Further, CIDCO vide letter dated 23.4.1994 granted approval to revised plans and CC was issued on 25.4.1994. PP further presented that the current matter pertains to commercial building on plot No. 7-B, Sector 11, C.B.D., Navi Mumbai.

PP presented that the construction is completed on the site under reference based on the development permission and commencement certificate granted by NMMC. The site falls in CRZ II area. Now, the matter is pending before NMMC for issuance of Occupation Certificate.

The Authority discussed the matter and noted that commencement certificate (CC) was provided to the subject proposal by the concerned planning Authority on 20.12.1993 & 25.4.1994 which predates the date of approval of CZMP of Maharashtra in 1996 as well as MCZMA's reconstitution order dated 4.1.2002, which empowered the MCZMA to examine all the projects in CRZ area. The Authority further noted that CRZ Notification, 1991 was in force when the CC was granted by CIDCO to the project and the concerned authority at the State level was empowered to regulate the activities from CRZ point of view in CRZ areas as per para 6(2) of CRZ Notification, 1991. The Authority assumed that concerned planning

authority would have exercised due diligence with regard to CRZ Notification, 1991 before granting development permission/CC to the said proposal.

In view of above, the Authority after detailed discussion and deliberation decided that the matter needs to be dealt by concerned planning Authority appropriately at their level for issuance of OC to the project since the matter predates the Coastal Management Plan & also Authority.

Item No.4: SRA Scheme on plot bearing CS No.1980(pt), Fort, Plot No.153A(pt), Backbay reclamation Scheme III, Nariman Point, Mumbai

The Authority noted that the matter was considered in 92nd Meeting of MCZMA held on 19.7.2014, wherein the Authority noted the background of the matter and decided the following:

- Site visit will be carried out in order to see whether construction is landward side of imaginary line.
- SRA should present the matter before the MCZMA about the construction of sale building.

Accordingly, the site was visited by the MCZMA sub-committee on 29th October, 2014. The team observed that:

Construction of one rehabilitation building is completed. Construction up to plinth level was observed completed for second rehab building at the site. SRA official informed that, out of the 150 slum dwellers, 132 have been rehabilitated in the completed rehabilitation building. Remaining 18 people will be rehabilitated in the second rehabilitation building. Construction work of basement was also observed at the site of second rehabilitation building. Only site development (excavation work) of sale building was seen at the site and no construction work was observed. SRA officials informed that sale building work was stopped, since SRA has sought a clarification from MCZMA in the matter.

SRA officials pointed out the demarcation of imaginary line drawn parallel to the HTL joining two authorized structure constructed prior to 19.2.1991. SRA official showed the reference points which were marked by CESS while demarcation of imaginary line. The team observed that the construction is proposed on the landward side of the imaginary line.

The Authority noted that site visit report of the subcommittee was taken on record in its 94th meeting held on 24th & 25th Nov, 2014 and decided to discuss the matters in next meeting.

The Authority after detailed discussion and deliberation decided the followings:

- 1. SRA is directed to put pillars to indicate imaginary line for the project under reference as per plan/CRZ map prepared by Centre for Earth Science and Studies, Kerala, which is one of the agency authorized by MoEF. SRA will intimate the compliance to MCZMA
- 2. The stop work order issued to the project was revoked by MCZMA vide letter dated 1.10.2012. This revocation order of MCZMA is for SRA scheme on plot no. 153 A(pt), Backbay Reclamation Scheme III, Nariman Point, Mumbai.

Item No.5: SRA Scheme on plot bearing CTS No. 791 (pt) of Mahim Bandra Reclamation Area for Jamat –E-Jamhooria CHS by M/s. Pyramid Developer

The Authority noted that the matter was earlier considered in the 93rd meeting held on 25.8.2014, wherein the Authority heard the complainant, Developer and SRA officials. In the said meeting, the Authority decided the followings:

- a. SRA should ensure that the construction work is stopped on site. SRA should submit the compliance to MCZMA regarding the stop work notice issued by the Environment Dept to the M/s Pyramid Developer. UDD has been requested by MCZMA to provide details of permissible FSI for the SRA scheme as per norms existed as on 19.2.1991.
- b. SRA should submit area details of LOI of 2003, 2007 & 2010 with comparative FSI statements within 15 days period.
- c. Upon receipt of information mentioned at Point No. 1, 2 & the report from UDD, the MCZMA will decide further appropriate action in the matter.

The Authority noted that SRA vide letter dated 18.9.2014 submitted its reply.

The Authority further noted that the MCZMA vide office noting dated 14.8.2014 requested Urban Development Department (UDD) to provide remarks on permissible FSI as existed on 19.2.1991 for the project under reference. UDD vide office noting dated 23.12.2014 forwarded their remarks on permissible FSI as existed on 19.2.1991 for the project under reference to MCZMA.

The Authority noted that UDD vide above said office noting in Marathi has informed that for Bandra Kurla Complex notified area, FSI permissible for residential development as per DCR as on 19.2.1991 is 1.5. Further, UDD has informed about a directive dated 4.11.1988 under section 154(1) of MRTP Act, 1966 with respect to rehabilitation of slums mentioning applicability of additional FSI not exceeding 25% of the normally permissible FSI.

The Authority noted that Chief Minister, GoM in the office noting mentioned that the stand of UDD in respect of permissible FSI as on 19.2.1991 for SRA scheme under reference be communicated to MoEF, New Delhi to take note of it.

The Authority after deliberations decided that matter be sent to Environment Department, GoM for further communication to MoEF.

Item No.6 to 65: Bay proposals received before the MCZMA.

The Authority in its 96th meeting held on 17th Jan, 2015 has decided that Authority shall decide the cases of Bay matters on case to case basis on merit in accordance with provisions of CRZ Notification, 2011 and the report & CRZ map in 1:4000 scale prepared by one of the agencies authorized by MoEF & National Hydrographer office, Deharadun letter for recognition coastal water body as a 'Bay' & other relevant issues. Further, the Authority also decided to wait for opinion of Advocate General (AG), GoM in the matter as the matter is with office of AG.

The Authority therefore examined various cases of Bay received before the MCZMA on case to case basis on merit in accordance with above decision seeking exemption from CRZ Notification, 2011.

Minutes of the 97th Meeting of Maharashtra Coastal Zone Management Authority held on 23rd January, 2015

Authority noted that as per para (ii) of CRZ Notification, 2011, CRZ area extent is max 100 m from High Tide Line of tidally influenced water bodies including Bays.

The Authority categorized the sixty (60) Nos. of Bay cases (Mahim Bay, Back Bay & Ambolgadh Bay) received before MCZMA as tabulated below into three (3) list namely List A, List B and List C based on the provisions of CRZ Notification, 2011 & CRZ map in 1:4000 prepared by one of the agency authorized by MoEF & report/corrigendum.

List A: Proposals involving followings aspects:

- 1. Demarcation of HTL for Bay carried out by MoEF authorized agency is corresponding to HTL of approved CZMP subjected to generalization error due to scale of mapping.
- 2. CRZ map & report/corrigendum of MoEF authorized agency submitted which concludes the plot under reference of the proposals falling outside 100 m CRZ line from HTL of **Bay** as the case may be, as per approved CZMP.
- 3. NHO letter/ report clarifying/certifying that water body as Bay & also depicted as Bay on their official navigational charts.
- 4. CRZ map shows two (2) water bodies i.e Bay & Arabian sea in certain cases. However, these sites are far away from Arabian sea. Hence, site mainly fronts Bays.

AND

- 1. Demarcation of HTL for Bay carried out by MoEF authorized agency wherein the HTL drawn by MoEF authorized agency is not same as that of old HTL shown in approved CZMP. Both HTLs (old approved & new draft) are demarcated on CRZ map. However, the site of proposal is outside 100 m CRZ line from approved HTLs of Bay.
- 2. Report of MoEF authorized agency also concludes that sites of proposals are outside 100 m CRZ line from old approved HTL of Bay.
- 3. CRZ map shows two (2) water bodies i.e Bay & Arabian sea in certain case. However, report clearly mentions HTL of Arabian Sea corresponds to HTL shown in approved CZMP. Further, HTL demarcated by MoEF authorized agency for Bay is not same as that of old approved HTL of Bay. However, site falls beyond 100 m CRZ line from approved HTL of Bay.

List B: Proposals wherein compliance is necessary, such as:

- 1. As to whether HTL demarcated by MoEF authorized agency corresponds to HTL shown in approved CZMP. If not, HTL as per approved CZMP along with its 100 m CRZ area on the map should be shown in case of Bay/creek.
- 2. Clear conclusion in the report of MoEF authorized agency is not mentioned as to whether site falls beyond 100 m CRZ line from approved HTL of Bay and beyond 500 m CRZ line from
- falls beyond 100 m CRZ line from approved HTL of Bay and beyond 500 m CRZ line from approved HTL of Arabian Sea, as applicable.
 - 3. Inconsistence observed in CRZ map & report of MoEF authorized agency.

List C:

Proposal wherein the HTL demarcated by MoEF authorized agency is not same as that of approved HTL of Bay. HTL as per approved CZMP is traversing the plot area resulting in falling substantial portion of plot in CRZ I area and considering the 100 m CRZ area from approved HTL of Bay, balance portion of plot is falling in CRZ II/III area,

The Authority noted that National Hydrographic Office (NHO), Dehradun vide letter dated 28.9.2013 has clarified that as per records of their office, Mahim Bay and Back Bay are considered as Bay and are also depicted as Bays on their official navigational charts. Further, above said Bay matters are not before Hon'ble High Court for deciding CRZ status, as of now. Authority further noted that as per Notification dated 7th May, 2014 issued by MoEF, the approved CZMP will be used till 31st Jan, 2015.

The Authority observed that proposals covered under List A can be considered for exemption from CRZ area, as per provisions of CRZ Notification, 2011. Further, compliance is required for proposals covered under List B. And proposal mentioned in List C can not be considered for exemption from CRZ area as per provisions of CRZ Notification, 2011.

The Authority further discussed that the opinion of Advocate General, Govt of Maharashtra is still awaited in the matter and decided that appropriate decision on the proposals of Bay would be taken after receipt of AG's opinion.

Item No.66: Proposed construction of Anti-Sea Erosion Bunds at Mumbai, Thane, Raigad, Ratnagiri, Sindhudurg Districts by Maharashtra Maritime Board (31 Proposals)

Maharashtra Maritime Board (MMB) presented proposals for construction of anti-sea erosion bunds to protect people, livestock and agricultural fields from coastal erosion. The objective of the project is also to create suitable infrastructure to mitigate the effects of cyclones in the coastal areas. MMB has submitted rapid EIA for the projects in the districts of Thane, Raigad, Ratnagiri, Sindhudurg, Muinbai city & Suburban.

Project proponent was absent for the meeting. Hence, the matter was deferred.

Item No.74: Proposed Hotel & Beach Resort project, village Sagartirth - Survey no./ Hissa no. 2/3 B, 4/1, 4/3, Tank – survey no./hissa no. 16/1/1, 16/1/4, 27/1/2 & Temb – survey no. / hissa no. 15/1/1 A, 15/1/2, Tal. Vengurla, Dist. Sindhudurg by M/s Elite Town Ship Pvt. Ltd.

Project proponent (PP) presented the proposal before the Authority. The Authority noted the followings:

- The proposal is for Hotel & Beach Resort project, village Sagartirth Survey no./ Hissa no. 2/3 B, 4/1, 4/3, Tank - survey no./hissa no. 16/1/1, 16/1/4, 27/1/2 & Temb - survey no. / hissa no. 15/1/1 A, 15/1/2, Tal. Vengurla, Dist. Sindhudurg. District Collector, Sindhudurg vide letter dated July, 2014 forwarded the proposal to MCZMA.
- 2. As per the CRZ map indicating HTL & LTL demarcated by NIO, Goa in 1:4000 scale, the site partly falls in CRZ I, CRZ III i.e. (partly within 200m from HTL, partly within 200-500m from HTL & partly beyond 500m from HTL)
- 3. As per the revised Maharashtra Regional & Town Planning Authority, the land under reference falls in Tourism zone (T-2).

- 4. As per the Notification UDD, 1991 and the Sindhudurg District Tourism Plan, the site falls under Exclusive Tourism Zone (T-5) category
- 5. Total area of plot is 2,19,084sqm (54.13Acres)
- 6. Maharashtra Pollution Control Board (MPCB) has granted consent on dated 13.02.2013, for a period up to commissioning of the unit or 5 years whichever is earlier.
- 7. Salient features of the project is as follows:

As per site layout plan submitted by PP:

- Total Plot Area: 2,19,084 Sqm.
- Area between HTL & 200 m CRZ line:1,16,328.92 Sqm
- Area between 200 m to 500 m CRZ line:1,02,755.08 Sqm.
- Total Built up area:61,926. 22 Sqm.
- FSI permissible- 0.33 & proposed FSI- 0.17.

Authority noted that PP submitted Environment Impact Assessment report and Environment Management Plan. PP has addressed the issues of ecology, impact on air environment, water environment and noise environment and measures are proposed in EMP during construction and operation phase.

Authority noted that MCZMA vide its letter dated 09.01.2015 sought information on certain points from the PP. Accordingly, the PP vide letter dated 13.1.2015 submitted the required information to MCZMA. The Authority observed that the proposal is in accordance with guidelines stipulated in Annexure III of CRZ Notification, 2011(amended time to time) and can be permitted in CRZ III area.

The Authority decided to recommend the proposal from CRZ point of view to MoEF subject to strict compliance of following conditions:

- 1. The proposed construction should be carried out strictly as per the provisions of CRZ Notification, 2011 (as amended from time to time) and guidelines/ clarifications given by MoEF from time to time.
- 2. The project proponent should comply with the guidelines stipulated in Annexure III of CRZ Notification, 2011(amended time to time).
- 3. PP should implement Environment Management Plan effectively during construction and operation phase of the project activities.

- 4. There shall no construction activity of the project within 200 m from HTL of sea, as per approved Coastal land use map.
- 5. PP should submit the superimposition of HTL & 200m, 500m. CRZ boundaries, as indicated in approved Coastal land use map of area unto the CRZ map in 1:4000 scale prepared by NIO, Goa.
- 6. There shall be no construction activity, no digging activity for rainwater lagoon within 200m from HTL of sea.
- 7. Natural depression will be used to gather the water. Sample of the water should be collected and submitted to MPCB and ambient water quality standards should be ensrued.
- 8. PP shall install water meters and it should be ensured that water consumption does not exceed the quantity of water allotted to them by Maharashtra Jeevan Pradhikarn / Irrigation Dept, GoM.
- 9. There shall be no disposal of sewage or solid waste into the sea during construction & operation phase.
- 10. PP shall carry out plantation in the periphery of the project area comprising of predominantly local species.
- 11. PP, during operational phase shall put up a display board that public will have access to Beach fronting the project area. PP should no erect / install any construction like umbrella etc on the beach area.
- 12. PP shall put up a display board that the said beach resort does not discharge any waste into the sea.
- 13. There shall not be redevelopment activity of the old existing structure as of now.
- 14. Sewage generated shall be treated adequately with primary, secondary and tertiary treatment arrangement to ensure recycle of treated effluent to the maximum extent and remaining shall be utilized for landscaping/gardening after appropriate disinfection. STP shall be located in area other than CRZ I area.
- 15. Sludge generated from Sewage Treatment plant shall be used as a manure and excess sludge(dry form) should be given to farmers free of cost.
- 16. PP should ensure that, in case of malfunctioning or failure of STP, sewage would be transported by authorized tankers to other authorized treatment site where adequate treatment to the sewage is given before its scientific disposal.
- 17. Municipal Solid waste shall be collected and disposed in a scientific manner. Organic waste of the MSW will be converted into a compost. Processing plant of the organic waste shall be located outside CRZ area. Other MSW shall be disposed scientifically at designated site outside CRZ area.
- 18. PP should ensure that the management of Hazardous waste i.e. spent oil is in accordance with Hazardous waste Management & Transboundary boundary rules, 2008.
- 19. No labor camp, machineries and material storage is allowed in CRZ area & it should also be ensured that the waste water from these entities should not be released into the coastal water body.
- 20. All other required permission from different statutory authorities should be obtained prior to commencement of work.

Compliance of the above conditions should be ensured by concerned project incharge.
